## Organization

The BLM manages more land – 256 million acres – than any other Federal agency. This land, known as the National System of Public Lands, is primarily located in 12 Western states, including Alaska. The Bureau, with a budget of about \$1 billion also administers 700 million acres of sub-surface mineral estates throughout the nation. The BLM's multiple-use mission is to sustain the health and productivity of the public lands for the use and enjoyment of present and future generations.

## Requirements

All applicants must be United States citizens and at least 18 years of age by the time of appointment. Applicants with experience or training in the fields for which they are applying may qualify at higher grades. All positions require the applicant to pass a physical examination. All applicants will be considered without regard to political, religious, or labor organization affiliation or non-affiliation, marital status, race, color, sex, sexual orientation, national origin, non-disqualifying physical or mental disability or age.

2. Faxed or uploaded copies of supplemental application documents (DD-214, transcripts, etc.). Please remember to fax or upload all supporting documentation using the Upload feature or Auto-Requested Fax feature described in the REQUIRED DOCUMENTS section of the vacancy announcement. Copies of the applicable documents must be submitted for each vacancy that you apply for.
